Board Action: Motion by Councilman Paschkes, seconded by Councilman Falco, all voting aye to open the Public Hearing to consider approval of Pound Ridge Partnership request for a "Pocket Park" in Scotts Corners.

James Best along with Valerie Price, representing the Partnership, gave an overviewl of the proposed "pocket park" between 70 and 72 Westchester Avenue. There is currently a path that they will take out and replace it with the same brick sidewalk connecting it with the existing sidewalk on Westchester Avenue through to the back. They would also like to put in a serpentine wall as a retaining wall because there is a grade that slopes and they will put in plantings. This would be the first phase of the project. The second phase of the project would be to continue the plantings and the walkway through the parking area in the back.

The Planning Board gave their approval for the "pocket park" at their March 22, 2012 Planning Board meeting.

Town Counsel, James Sullivan, mentioned that the Town is currently working on a revised, accurate map of the Parking District. He also asked if they have made any arrangements with the contiguous property owners regarding liability insurance. James Best said that at the current time, the liability will be covered by two property owners on which the park is built. Town Attorney Sullivan asked who would be maintaining the proposed "pocket park". James Best said that the property owners agreed to keep that sidewalk shoveled and the Partnership would also have volunteers to keep up the maintenance. One shop owner, Audrey Free of Plum Plums, also volunteered to maintain the park.

Board Action: Motion by Councilman Falco, seconded by Councilman Paschkes, all voting aye to close the Public Hearing to consider approval of tow Property Owners and Pound Ridge Partnership's request for a "Pocket Park" in Scotts Corners.

Susan Grissom and Teri Pike gave a synopsis of what is planned for the Pound Ridge Pride Festival. The beginning of the festival will be beautification of the Parking District with community services planting and painting signs and cleaning up the islands near the shops and possibly educating people about plantings. They will possibly celebrate the opening of the "pocket park" at the same time. The Partnership brings together three elements: beautification, education and community.

They have reviewed the logistics with Police Chief David Ryan, which include having the street closed with many activities going on including food, pie-eating contests, possibly a micro-brewery and music. This festival is also co-sponsored by the Pound Ridge Library.
