NEW BUSINESS:

Insurance Renewal for 2011-2012

Thomas Sternberg, SKCG Group, Inc. was present to give the Town Board a review of the insurance renewals for the year 2011-2012 effective June 18, 2011. Most carriers are looking for increases of 5-10% due to US and abroad natural disasters. Our increase has been negotiated to around 2% or a total of \$2,091. Our Worker's Comprehensive Plan coverage comes up in January 2012, but Tom explained that there will be an increase in most municipalities of no less than 27% and as much as 56% in some cases. The State of New York has increased Worker's Compensation benefits by 85% since 2007. The weekly reimbursement to injured workers has gone from \$400 to

\$739 per week. Additionally, the judiciary has given a more liberal interpretation of what is a work related injury. Many more employees have the court deciding that it is a work related injury. The State also did away with the second injury fund where a worker who is injured and then injured again could apply for relief from the State instead of the employer. Medical services have also increased and most importantly, the Police and Fire fighters have the 207C cases. SKCG Group has been able to keep a competitive and comprehensive renewal program from Selective Insurance. They are recommending that the Town continue to stay with Selective Insurance. Our volunteer Town Insurance Advisor, Harvey Dann has received a copy of this renewal proposal and recommends staying with Selective because they are reliable and competitive. Harvey also mentioned that the fact that the Town has a Safety Committee reflects discounts with the Worker's Compensation proposal. Harvey said that the rate on our property is incredibly low at 10 cents for \$100 worth of insurance. The automobile rates are also incredibly low. The equipment rate is a little higher but is still a good rate.

Councilman Paschkes asked Tom to look into possibly locking into a multi-year contract instead of an annual contract. Tom will look into this and get back to the Town Board tomorrow.
