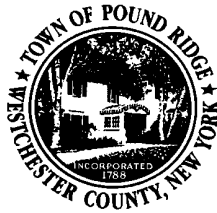

Bids must include 1) the page(s) pertaining to the relevant material(s) or service(s), 2) a signed non-collusion statement, and 3) proof of insurance.
