CALL TO ORDER: Supervisor Hansan called the meeting to order at 8:00 p.m.

CALL FOR EXECUTIVE SESSION: None

ANNOUNCEMENTS:

- Councilwoman Sullivan reminded everyone to be a donor volunteer as February 14, 2018 is National Organ Donor Day.
- Councilman Paschkes confirmed that there is a public Q & A meeting scheduled in Pound Ridge with Representative Sean Maloney at 2:30 p.m. this Sunday, February 11, 2018 in the Courtroom.

MINUTES: Acknowledge/correct/accept minutes of Town Board Meetings on February 1, 2018

<u>Board Action:</u> Motion by Councilwoman Sullivan, seconded by Councilman Paschkes, all voting aye on the following:

PUBLIC HEARING: Economic Development Committee

Board Action: Motion by Councilman Paschkes, seconded by Councilwoman Briggs, all voting aye to open the Public Hearing on the proposed Economic Development Committee.

The concept of creating the Committee is to promote, encourage and support local businesses in Pound Ridge which is now under the Business Association and Pound Ridge Partnership. The Committee will try to include all businesses in Pound Ridge even if they are not in the Business District. It will be formed to improve business and get the word out to the public to come shop Pound Ridge. The Committee will take the input of residents and the public and provide feedback to the business owners. This would be an advisory committee made up of local residents and businesses. Supervisor Hansan drafted a proposal for the committee with preliminary set of ideas that could easily evolve through community input.

Many residents spoke in a positive acceptance of the Economic Development Committee and want to encourage business in Pound Ridge. There is some concern about over Page No. 2 MINUTES OF THE MEETING OF THE TOWN BOARD TOWN OF POUND RIDGE POUND RIDGE, NY FEBRUARY 8, 2018

development and they wanted make sure that doesn't to happen. Another resident asked that we pay more attention to the PB-C district and suggested putting in more sidewalks at that end of the business district to encourage business owners to walk into Town for their shopping and dining. Some residents spoke about how vibrant the business district was in the 1980's but it somehow lost its appeal. The improvements through the TEP Project and this Committee can bring back the appeal. There should be a coordinated effort with the various Boards and Commissions we have in Pound Ridge as well.

Another resident mentioned that the various home-based businesses should be included and they should be allowed from time to time to actually display their wares or inform the residents of their businesses. It was also mentioned that we have a Comprehensive Plan that needs to be revisited from time to time because of all the important information it holds.

Supervisor Hansan asked that we close the Public Hearing and then have a discussion amongst the Town Board members for their thoughts.

Board Action: Motion by Councilwoman Sullivan, seconded by Councilwoman Briggs, all voting aye to close the Public Hearing on the proposed Economic Development Committee.

Discussion followed by the Town Board members. Councilwoman Briggs started by saying she is very excited about the concept of the Committee and loves the fact that all business owners can come together and share resources and support the district.

Councilwoman Sullivan wanted to remind people that this is strictly an advisory committee and they cannot enforce anything. Their opinions and ideas are always welcomed. She is concerned that their ideas may exceed the actual business district as we are limited to one street and how much can be put in that district. Over the years businesses have changed as new people and demands came in. There is also the use of on-line shopping for everything that has hindered the local businesses. The Committee would also have to be mindful of the septic problems we have in our business district and think of possible solutions. Councilwoman Sullivan is in favor of the business growth but warns to be realistic and flexible in their thinking.

Councilman Paschkes is very excited about this Committee and hopes for success. His only concern is with item # 6 of the outlined draft that states: "Provide prospective business owners with assistance in site selection, business expansion, listings of available properties, and understanding existing zoning regulations and restrictions". It is not appropriate for a Town Committee to be involved with site selections or giving legal advice to potential business owners. That is up to the Boards and Commissions of the

Town of Pound Ridge. He feels that item should be eliminated or rewritten. Counsel Harrington will work on that.

Two business owners who could not be present for the Town Board meeting sent in their thoughts and both are positive. Donna Simons expressed that the three business districts, PB-A, PB-B and PB-C should all be represented and included and that she is willing to serve on the Committee. Fred Albano wanted to say he is very supportive and hopes that there wouldn't be any duplication of what has already been done.

The issue to create the Economic Development Committee was tabled for a vote at a future meeting.

NEW BUSINESS:

• Community Choice Aggregation: Sustainable Westchester update

Dan Welsh, Westchester Power, a program of Sustainable Westchester addressed the Town Board regarding Community Choice Aggregation updates. Sustainable Westchester, Inc., a not-for-profit organization comprised of several municipalities in Westchester County, including the Town of Pound Ridge, created a Community Choice Aggregation ("CCA") program in Westchester County, which would allow local governments to participate in a Sustainable Westchester program to procure energy supplies from energy service companies ("ESCOs") for the residents of the municipalities. In 2015, the Public Service Commission of the State of New York approved implementation of the first community choice aggregation ("CCA") pilot program in New York State, which allows Sustainable Westchester to put out for bid the total amount of natural gas or electricity being purchased by local residents or small businesses. The program provided consumers with the ability to lower their overall energy costs, and the potential benefits of CCA programs include price stability for a fixed contract term, lower prices, more favorable contract terms, and the ability to design a program that reflects local preferences and needs, including a preference for cleaner power sources.

Twenty municipalities have joined the CCA program and fourteen of them chose the 100% renewable energy option. Dan Welsh provided a residential rate comparison: NYSEG vs. WP and it shows an average of \$90 savings per account which includes the supply cost savings and the delivery sales tax that is avoided. The NYSEG contract currently runs through 2019, so there is no guarantee that they can take Pound Ridge in on it. Dan Welsh said that Sustainable Westchester will try to get them to take us on mid contract if the Town Board wanted to go that route. They would have more public sessions prior to signing up for the CCA program. If Pound Ridge joined, it would mean that the residents would automatically be signed up with the option to opt out at any time.

Councilman Paschkes reminded the Town Board that a Local Law was adopted in 2015 establishing a Community Choice Aggregation (Energy) Program in the Town of Pound Ridge to move on this once the Town was ready and had enough information to see if it was a savings to the residents and was a program that truly worked. Dan Welsh explained that there were a few glitches/issues that have been worked out. Councilman Paschkes feels that it is worth revisiting and that Dan Welsh should hold follow up informational sessions to inform the public about this program. After the informational sessions, a Public Hearing would need to be scheduled to get feedback from the public and to see if the majority of the residents are actively in favor of the program for Pound Ridge.
