## **Pound Ridge Economic Development Committee**

## **Committee Charge:**

The Mission of the Pound Ridge Economic Development Committee is to promote, encourage, and support local businesses in Pound Ridge and make Pound Ridge an economically vibrant community where people work, shop, dine, and enjoy services and

recreation in Pound Ridge. This will be accomplished by involving established business organizations, Town Government Boards and Commissions, and Town residents.

Committee members are charged with recommending a comprehensive strategy to the Town Board to:

- 1. Promote coordination and communication between and among:
  - a) Residents
  - b) Local Businesses
  - c) Town Government
  - d) Town boards/commissions especially planning, zoning, water commission, and the water/wastewater task force
  - e) Other towns.
- 2. Coordinate Community Calendar to maintain active content about the activities in Town that could promote commerce in our local business district.
- 3. Assist in the development of branding and active marketing to promote Pound Ridge small businesses and the Scotts Corners business district.
- 4. Recommend guidelines for the aesthetics of the Scotts Corners business district.
- 5. Recruit businesses and services to Pound Ridge which support the brand and as desired by residents.
- 6. Interact with and encourage existing and prospective business owners to develop a more vibrant business community.
- 7. Update the Town's Website about the Pound Ridge Economic Development Committee and its services.
- 8. Deliver a report detailing the progress made towards promoting, encouraging, and supporting local businesses in Pound Ridge annually to the Town Board.

# **Structure/Members:**

The Committee shall have 2 permanent positions reserved for representatives of the existing town business organizations, 4 Pound Ridge resident members at-large appointed by the Town Board, and 1 Town Board member appointed by the Town Board. There will be 2 Co-chairs. One Co-Chair will be the Town Board member and the other will be selected by the remaining members and confirmed by the Town Board. Co-Chairs for this committee will serve one-year terms and may be re-appointed by the Town Board each year. Committee members At-Large will serve 5- year terms.

• Energy Action Committee- request/recommendation to adopt revised Energize NY PACE law as amended by NYS

The Energy Improvement Corporation gave a memo to the Town Board dated December 4, 2017 regarding revisions to EIC's PACE Finance Services. New York State has

amended its PACE Law to make PACE financing more accessible to clean energy projects. The changes will expand the usefulness of Energize NY PACE and increase its appeal to energy efficiency and renewable energy project developers. The individual municipalities need to amend their local PACE law to conform to the new template that EIC has provided. Sarah Smiley, Director of Member Services/Energize NY explained the proposed amendments to the Town Board. Ms. Smiley mentioned that one amendment with the renewable energy system states that "to be used primarily at such property, except when the Qualified Property Owner is a commercial entity in which case the system may be used for other properties in addition to that subject property". One of the advantages is to help owners with lower property values, enabling EIC to increase the maximum amount of available PACE financing relative to a property's value and provides more flexibility going forward. It would also expand the benefits of community solar projects. It would adopt commercial case guidelines used by NYSERDA.

The next step would be to call for a Public Hearing in the near future to adopt the proposed amendments subject to review by Town Attorney.
