#### ADD ON: Stadium Seating in the Town Park:

Dave Goldberg, Superintendent of the Recreation Department said that the Pound Ridge partnership funded stadium seating will be open for the official start of Baseball Season which is on April 13<sup>th</sup>. The seating area is behind the baseball field diamond near an 8ft grassy wall where you can sit with a chair. There is also an inflatable plastic dome for the seating area.

The upgrade to the tower included removing three antennas, adding six new antennas and adding nine radio heads to the existing tower. The Town Board said that they can proceed as outlined in the Special Use permit submitted by the Sprint Corporation.
