Richard Wetchler, Chair of Recreation Commission and David Goldberg, Recreation Superintendent learned about a grant that is available through New York State Parks,

Recreation and Historic Preservation Environmental Protection Fund Grants Program including rehabilitation of swimming facilities. Grant awards up to \$600,000 are available and if the project is greater than \$4 million, then \$1 million is available. The project must be completed in 5 years and there is a 50% match required including cash, payroll expenses for staff work on the project; professional services, supplies and materials, volunteer labor. The Town kiddie pool needs to be replaced and the recreation and competition pool need permanent repairs. There is a timeline to follow, so they are looking for authorization to apply for the grant tonight then they will get at least two professional quotes/proposals for the job/project. Dave Goldberg mentioned that he has a quote from Lothrop Associates from a time before and he will reach out for 2 other quotes.

## • Highway Department – Discussion of speed humps on West Lane

Councilman Paschkes asked the Town Board to discuss the speed humps on West Lane. Currently, the three speed humps are not built to code and could potentially cause problems. He would like to see them built to code and gave an example of the newly placed humps in the Town of Bedford off Route 172. Apparently there are two different types of speed humps, one for pedestrian crosswalks and the other for traffic roadway. They have been proven to successfully slow traffic. He would like the ones on West Lane reconstructed or replaced to meet NYS Department of Transportation code guidelines.

Many residents from West Lane were present at the meeting to voice their opinions on the speed humps. Wendy Weinberg of 52 West Lane asked why they were put there in the first place. Councilman Paschkes answered to make vehicles slow down and to try to eliminate the volume of cut-through traffic. Mrs. Weinberg also asked who decided where to put the three humps and Councilman Paschkes said it was the Town Highway Department who placed them where they thought it would get the greatest impact. She doesn't feel they are effective and finds the vehicles slowing down just to go over the humps and then speeding back up for the rest of the roadway. She said it is very

dangerous trying to get out of her driveway and getting the mail. She would like more done to eliminate the volume and speed of vehicles and suggested posting signs.

Clay Bassett of 15 West Lane said that the speed humps have blunted the danger but didn't solve the problem. He would like to have more speed humps added and keep the height of them. That may deter vehicles from using it as a cut-through road. He also finds it hard to get out of his driveway and fears the life of anyone walking on West Lane or riding a bicycle. Something has to be done and the answer is not to make it up to code.

Richard Danzker of 44 West Lane agrees with the other neighbors that spoke and mentioned that double yellow lines were recently put in and it causes people to believe it is a faster road to drive on. He suggests taking the yellow lines away and that may help deter the speeding.

Andrew Philip of 27 West Lane suggested putting up signage that would eliminate the cut-through use of commercial vehicles and also if a sign said there were speed humps ahead, some vehicles may decide to take another road.

Samantha Brown of 41 West Lane also said she is very concerned about the speed and volume of vehicles and she has small children to worry about all the time. She also asked who would be reconstructing the humps if the Town decided to do that and who would pay for the work. The Town's Highway Department would be responsible for the work and the Pound Ridge taxpayers would be responsible for the cost.

Councilwoman Jody Sullivan of 74 West Lane mentioned that she has received 13 emails from residents of West Lane stating that they all believe it is dangerous and it was suggested to add more humps on every curve of West Lane to help slow down traffic and eliminate some of the dangerous situations.

Councilman Dow asked if anyone has a record of how many accidents occur on West Lane and it was mentioned that Chief David Ryan may have the statistics on that.

Another suggestion was given to paint the humps to be more visible. It was also suggested to have Vinnie Duffield, Highway Superintendent, come before the Town Board to discuss what is involved with getting the speed humps up to code.

Council Harrington suggested putting together a sub-committee consisting of the residents of West Lane, a Town Board representative, Highway Superintendent and the Chief of Police to discuss all of the suggestions and concerns. There are a few ideas to oversee West Lane challenges and this should be discussed and possibly come up with a solution. Councilman Paschkes offered to represent the Town Board. The residents left saying that was a great idea and will follow through with setting up the sub-committee.
