• Assessor – Authorization for new MLS fee

### • EDC – call for letters of interest on 77 Westchester Avenue

Councilwoman Diane Briggs explained that there was an offer on the table for the property at 77 Westchester Avenue to purchase the property and make a passive park. That offer will go away before the holidays if a decision is not made to accept it. There has been discussion that it may not be the best offer in the interest of the Town. The Economic Development Committee will seek letters of intent/interest and further discussion will take place in the next couple of months. The Town Board will be copied on all proposals.

### • Highway – approval of temporary, regulatory signs on West Lane

Chief Ryan explained to the Town Board that the goal of traffic humps and signs are to reduce volume and speed on West Lane. There was some discussion of putting up temporary signs restricting use of West Lane during prime hours but Chief Ryan felt it wasn't necessary. He would like to purchase a piece of equipment that would collect data recording commercial vehicles, speed and how data from Waves and Google maps. This

will give a count of usage and the Town can patrol it accordingly. He will inquire if Bedford can lend us their equipment temporarily to "test" traffic and record data. Supervisor Hansan will send a letter to the residents of West Lane explaining what the Town plans to do. Supervisor Hansan will address this again in the next few weeks.

# • Planning Board – accept updated Stormwater Management Program

As a delegated state under the National Pollutant Discharge Elimination System program, New York administers EPA's Phase II Stormwater Rule. New York State has issued a Municipal Separate Storm Sewer System General Permit that details each of the conditions that must be addressed by the regulated small MS4 in order to be authorized to discharge stormwater. Pound Ridge first adopted a Stormwater Management program in 2003 and has completed the mapping of the existing stormwater infrastructure using a GIS data base.

Beth Evans, environmental consultant, updated the guideline of what we should be doing. The update requires Town Board approval.

### **RESOLUTION #: -161-19**

# - Report from NEW Dawn Family Resource Center

Richard Lyman, Secretary/Treasurer for NEW Dawn Family Resource Center, gave an update on the facility funded with the assistance of the towns of Bedford, Pound Ridge, Somers, Lewisboro and North Salem. The services at the facility include legal services, therapeutic services, counseling services, advocacy, law enforcement services and other victim focused needs to male and female victims of domestic abuse and their children. The IMA for the rent provided by the 5 towns expires December 2019. Each participating agency has recognized the value and importance of this life saving program and the team will remain intact.

There is currently a plan to mirror this program on a county-wide basis, implemented over the next year or two. This is the result of additional funding of \$900,000.00 to create a county-wide high-risk hotline.

Dick Lyman is asking the Town Board to approve a resolution to extend the IMA for another 2 years and to keep this program going. Supervisor Hansan will work with Chief Ryan and Dick Lyman on the language for the resolution which will be passed to allow the continuance of the IMA supporting the program and the expenditure of the annual rent towards the facility. This will be addressed at a future Town Board meeting.

Chief Ryan asked the Supervisor to write a letter of support to be sent to all participating municipalities so that they will all extend the IMA for another 2 years and keep New Dawn program.

• Town Clerk – -request for permission to advertise bidding of 2019-2020 Fuel Oil and Service contract
