# -Approval to adopt Citizens Cyber Notification Policy

Steve Conti, Director of Finance, is requesting approval of the Cyber Security Citizen's Notification Policy based on NYS requirements related to a cyber breach. This policy is consistent with the State Technology Law §208 as added by Chapters 442 and 491 of the laws of 2005. After determining that there has been believed to have been a compromise of the individual's private information, the Town must notify the individual by written notice, electronic notice, telephone notification or substitute notice (in excess of \$250,000) example e-mail, conspicuous posting of the notice or notification to major statewide media.

Councilman Paschkes suggested seriously considering budgeting for this software in the 2020 budget and not voting on it tonight. It was agreed to have it go through the budget process and approving it after that.

His sculpture is "Open Mind" and it is currently on display near the Key Bank in Scotts Corner. The sculpture uses a "brain cloud" cut-out to acknowledge the world in the sculpture saying a cloud changes its shape over time, as does the mind. After receiving the sculpture as a gift through Susan Grissom to the Pound Ridge Partnership from artist Lawrence McGarvey, the Pound Ridge Partnership Board voted to offer the sculpture as a gift to the Town of Pound Ridge.

- The Town will take full responsibility for the sculpture; i.e. maintenance, insurance, etc.
- The Partnership will have final approval on the location and method of display
- The sculpture's final location shall have a base and be lit.
