• Conservation Board-approval to conduct Urban Forestry Grant project

Carrie Sears, Chair of Conservation Board, is submitting a second request for a tree inventory and management plan for 141 acres of town-owned property in the Town Park, Pine Terrace, Slade preserve and cemeteries. The plan would identify trees and their health and make recommendation for risk management, future plantings and maintenance of the woodlands.
