The following Arbor Day Proclamation proclaims April 24, 2015 as Arbor Day:

*Whereas*, In 1872, J. Sterling Morton proposed t the Nebraska Board of Agriculture that a special day be set aside for the planting of trees, and

Whereas, the holiday called Arbor Day, was first observed with the planting of more than a million trees in Nebraska, and

Whereas, Arbor Day is now observed throughout the nation and the world, and

Whereas, trees can reduce the erosion of our precious topsoil by wind and water, lower our heating and cooling costs, moderate the temperature, clean the air, produce oxygen and provide habitat for wildlife, and

Whereas, trees are a renewable resource giving us paper, wood for our homes, fuel for our fires and countless other wood products, and

Whereas, trees in our town increase property values, enhance the economic vitality of business areas, and beautify our community, and

Whereas, trees, wherever they are planted, are a source of joy and spiritual renewal,

*Now, Therefore*, we, the Town Board of Pound Ridge, NY, do hereby proclaim April 24, 2015 ARBOR DAY in the Town of Pound Ridge, NY and we urge all citizens to celebrate Arbor Day, and to support efforts to protect our trees and woodlands, and *Further*, We urge all citizens to plant and care for trees to gladden the heart and promote the well-being of this and future generations.

Gail Jankus, Conservation Board Chair, spoke briefly about the aforementioned resolution and explained that declaring Arbor Day is necessary in order for Pound Ridge to be a Tree City. The Land Conservancy is doing a number of events including a Forestry Regeneration Workshop on April 18th; a Toddler Hike in Carolin's Grove on April 22<sup>nd</sup> and Restoration of Forest Edge habitats on May 2<sup>nd</sup>. That would cover requirements for Arbor Day. The Invasives Project-Pound Ridge, with funds from Henry Morgenthau Preserve has ordered native dogwood trees and small shrubs to be planted at the Town Park and Slade Preserve.

## Conservation Board- discussion becoming a Tree City

Supervisor Lyman, Councilman Paschkes and Councilwoman Schwartz joined the Conservation Board meeting with George Profous, Senior Forester with New York State DEC held on March 4, 2015. The Conservation Board feels that becoming a Tree City helps with educational purposes. Pound Ridge already has a Tree Ordinance which is one of the requirements and the Arbor Day Proclamation is another requirement. The Town would have to have an annual forestry program budget which is covered work by our Maintenance and Highway Departments. It has to be \$2.00 per capita and we are covered. Becoming a Tree City would possibly also give us an advantage on getting grants for a forestry management plan. The Town Park would be a wonderful place to

start. Gail suggested that the Conservation Board be named as Tree Board and the Town Board agrees.

Gail Jankus officially invited the Town Board members to attend the March 22, 2015 Forum at the Pound Ridge Library at 7:00 p.m. celebrating Pound Ridge becoming a Certified Community Habitat with the National Wildlife Federation.

Supervisor Lyman suggested that Gail complete the application for becoming a Tree City and the Town Board can then consider adopting the application.

On another note, Supervisor Lyman suggested that the Pound Ridge Land Conservancy be added to the list of approved non-for-profit vendors who can use Conant Hall free of charge.

## **RESOLUTION #: 65-15**

**Board Action:** Motion by Councilwoman Boak, seconded by Councilwoman Schwartz, all voting aye on the following:

RESOLVED, that the Town Board hereby approves the addition of the Pound Ridge Land Conservancy to the list of approved non-for-profit vendors who can use Conant Hall free of charge.

## • Adopt Resolution regarding the removal of PCBs from the Hudson River

Supervisor Lyman explained that the group representing Riverkeeper presented the Resolution Regarding the Removal of PCBs from the Hudson River to the Association of Towns monthly Supervisor's meeting. The group passed a resolution asking the Supervisor's to bring the Resolution back to their Town Board members for acceptance or rejection. The Resolution gives Riverkeeper's views but does not give General Electric Corporation's views. Riverkeeper is trying to put some light on this public resource saying the Hudson River communities deserve a PCB cleanup that will remove enough pollution from river sediments to allow the river to recover damaged natural resources and wildlife populations quickly and restore commercial and recreational activities. Supervisor Lyman asked the Board if they wished to adopt this Resolution in any form or not. The Town Board feels that Riverkeeper should provide more information and possibly make a presentation to the Town Board and possibly get a representative from GE to present their opinion as well for another viewpoint.

Councilman Paschkes said that he will try to contact Paul Jallay, President and Hudson Riverkeeper, to come and make a presentation and then extend an invitation to GE to come in as well. This can be scheduled for May.

## • Discuss changes to Personnel Policy Handbook

There were three (3) proposed changes to the Personnel Policy Handbook as follows:

## 1) Accident, Injury and Illness Reporting Procedures:

Word change, first paragraph:

In the event an accident, injury or illness occurs in the workplace which results in the summoning of Emergency Medical Services, the employee may not refuse medical attention. In the event any accident occurs in the workplace or during the course of employment which results in injury to a Town employee, damage to Town property, injury to a third party on Town property or damage to third party property, the following procedures will apply:

The Town Board discussed the legality of forcing or compelling an employee to receive medical attention. Councilman Paschkes is strongly opposed to this because there is no telling who calls 911 and why. There can be cases where someone overacts and call 911 and if we mandate this policy, any time 911 is called it mandates transport. It may have ramifications for the employee. They may be covering under a health insurance policy or may not be. Deputy Town Attorney John Loveless said that as written, you cannot legally force anyone to receive medical attention. The Town Board could; however, put a procedure in place and note the refusal. Everything that happens and all phone calls made must be well documented to cover the Town. We need to have a process in place to document everything as it happens.

# 2) Delete PERMA QUIK Report and add "the appropriate accident reporting form".

**Board Action:** Motion by Councilman Paschkes, seconded by Councilwoman Boak, all voting aye to accept the proposed word change in the second paragraph on page 25 under heading: Accident, Injury and Illness Reporting Procedures in the Personnel Policy Handbook deleting PERMA QUIK Report and adding "the appropriate accident reporting form".

3) page 37 B. sub-paragraph d.

Change last sentence to read: The schedule of the Administrative Assistant to the Chief of Police will be set at the discretion of the Chief of Police, but shall not be in excess of forty (40) hours per week except in times of emergency.

This was discussed and needed further explanation of what was to come of this. We need to have clarification of the wording and the Town Clerk will ask Chief Ryan. We will find out if she is hourly or salaried. We will revisit this at the April Town Board meeting.

## • Discuss adoption of Complete Streets Programs for Town of Pound Ridge

John Maddocks spoke about the Complete Streets Programs for the Town of Pound Ridge. He introduced us to the idea of Complete Streets are defined as safe, comfortable and convenient for travel for everyone, regardless of age or ability-motorists, pedestrians, bicyclists and public transportation riders. Complete Streets is a national idea, not a grant or program obligating the town to spend any money for initiating projects. It establishes an atmosphere to start thinking about future projects from a complete streets point of view. It only requires a resolution that we are a Complete Streets Town. Dr. Maddocks said that Pound Ridge is already a Complete Streets community because we have the walkway from A-Home to Town center and all the way down to the Town House and we also have the Transportation Enhancement Project (TEP) which will further demonstrate our interest in the Town. He would like us to formalize this in a resolution that we are a Complete Streets community indicating the Town's intention to follow Complete Street policies in all transportation projects.

Councilman Paschkes asked that Dr. Maddocks draw up a proposed resolution for the Town Board to review for adoption. Councilman Paschkes said that the operative language for us would be "encourages incorporating complete streets design practices to the extent feasible". He also suggested putting into the resolution that with regard to our Planning or Zoning Boards, they should take Complete Streets design into consideration when crafting their resolutions of approval. That would be the caveat for us. It can be used as a "guiding principle".

#### • Add-on: Energy Action Committee recognition ceremony

To date more than 40 homes have participated in the Energize Pound Ridge Program and in order to try to engage the community in the project, the Energy Action Committee is requesting a recognition ceremony at a Town Board meeting giving those 40 people that have participated a proclamation and brief reception.

## • Discuss proposed legislation on vacant buildings in the commercial district

Councilwoman De Palma continued the discussion on the proposed legislation on vacant buildings in the commercial district and restated the intent is to have owner contact information available to the Town and the second piece is to encourage occupancy of the buildings. Since the last meeting, Councilwoman De Palma has met with the Business Association and got positive feedback and met with Pound Ridge Partnership who also gave positive feedback. She took all comments and concerns and made a few revisions to the proposed ordinance as follows:

1. under Vacant Commercial Property: initially that if a property were vacant for more than 90 days, the owner would be required to register the property with the Town. The revision is to increase that time frame to more than 120 days.

Resident Peter Avellino couldn't understand why the Town wouldn't want to know that information or require the registration immediately instead of waiting 120 days. He feels her idea is a good one; however, he doesn't understand the waiting period. The trigger should happen immediately when a building is vacated. There should be a "responsible person" to notify as soon as there is a vacancy. There needs to be other ways to encourage renters; possibly staging the property.

- 2. under Owner: there was the omission of the requirement of a management person that would have to be separately funded and replacing it with a natural person designated by such entity to speak and act on behalf of the entity. It is very important to determine who this natural person is identified and have their address.
- 3. Added in the definition of "Actively Offered (for Rent or Sale).

In order to have the fee waived, sections A. Registration, B. Sign Posting and C. Fees must be followed. The steps have been clarified. Supervisor Lyman noted that in following the steps as proposed, the owner does not have the right to advertise on their own. This will be modified to allow the owner to list or advertise their properties on their own.

Councilwoman Schwartz had a problem with Section C. Fees (2) D. and E. where is states the Property is being actively offered for rent or sale at or below market rate. How can you stop someone from listing their property for more than market rate? This will also be looked into further and possibly revised.

Supervisor Lyman said that if a property is in danger to the community, then they should have to follow the certain steps but if the owner is taking proper care of the property, he doesn't see a compelling government interest in enacting this kind of

law. There could be a vacant property registration form so the Town has the proper contact information, but he doesn't feel we have the legal right to impose a penalty on someone who has not rented their building.

There seems to be a dispute of the fee amount as well. What one owner can afford, another may find it to be a hardship.

Councilwoman De Palma will incorporate the comments made tonight and amend the proposed ordinance for further discussion.
