CALL TO ORDER: Supervisor Lyman called the meeting to order at 8:00 p.m.

CALL FOR EXECUTIVE SESSION:

Board Action: Motion by Councilwoman Boak, seconded by Councilwoman Schwartz, all voting aye to hold an Executive Session immediately following the Town Board meeting for a legal matter.

ANNOUNCEMENTS/REMINDERS:

Supervisor Lyman had two announcements as follows:

- WRAPS (Westchester Recreation and park Society, Inc.) sent a letter to John Ritzcovan, Chair of Pound Ridge Recreation Commission, stating that he will be receiving the Public Service Award: Individual. He was nominated by David Goldberg, Superintendent of Pound Ridge Parks and Recreation. He is receiving this Voluntary Service Award because he has provided unselfish service on behalf of the residents of Westchester County and made an outstanding contribution of community services for at least three years since 2012. There is a luncheon for presentation of the award on Friday, June 12, 2015 at the Shenorock Shore Club in Rye, NY at 12:00 pm and all are welcome to attend.
- Supervisor Lyman announced our guest speaker for the Memorial Day celebration. The speaker will be our own Police Officer Thomas Turchyn who has 22 years of active and reserve duty in the US Army.

NEW BUSINESS:

• Schedule Public Hearing for Adopting CCA

The Town Board would like to schedule a Public Hearing for adopting the Community Choice Aggregation program that was discussed a couple of Town Board meetings ago. It is an opportunity and potential benefit in enabling efficiency, local renewable power and micro-grids. Somers, Lewisboro, Croton, North Salem and Bedford have already

adopted a resolution supporting this program and many other Westchester communities have presented it at their Town Board meetings. Supervisor Lyman will put information on this on the website for the public to review prior to the Public Hearing.

Councilwoman Boak, liaison to the Energy Action Committee, stated that the Committee is very much behind this and would like the Town Board to adopt this program.

RESOLVED, that the Town Board hereby schedules a Public Hearing for adopting the CCA (Community Choice Aggregation) on Thursday, June 11, 2015 at 8:00 p.m. at the Town House.

• Police Department – Deer Management

Jon Powers, Committee member, gave a brief synopsis of the existing Plan that has just completed its 9th year of operation. Since the start of the program, the total deer take has been 551. The Pound Ridge Deer Management program utilizes bow hunters to cull the deer herd while maximizing safety. The properties being hunted are: Sach's Park, Horseshoe Hill, Winterbottom/Indian Hill/Aquarion, Clarke Preserve, Bye Preserve, Armstrong Preserve and Aquarion Water properties.

Over the past nine years, there has been a variety of data collected and annual photographs have been taken to determine any type of forest regeneration and return of the under-story; and there has been some under-story recovery. It was also noticed that there has been a dramatic drop in car vs. deer collisions since the inception of the program. Jon Powers mentioned that there have been no accidents due to hunting, no wounded deer roaming on properties and no complaints from residents. We must continue to review our methods and discuss the program with private land owners, the Mianus Program, the Conservation Board, the Westchester Land Trust, the County Parks Department, NYC DEP, NYS DEC and our neighboring towns.

John and Jill Posner, residents, spoke highly of the program and said they have their property hunted as well. The hunters have been very respectful and professional and they encourage the continuation of the program.

The recommendations for the Deer Management Program are as follows:

1) Review the data collected by our DMAP partners to understand any level of regeneration to any degree and for whatever period it may occur.

- 2) Look to Westchester County as the collection point for all data collected to share and analyze that data and assist us in our planning as we move forward.
- 3) Consolidate the Richards preserve, Armstrong preserve and DEP property.
- 4) Require hunters on privately owned properties to report takes and possibly passing a local law requiring very specific reporting by hunters in Westchester County on the deer takes.

The Deer Management Committee would also propose a five (5) year program to get collective data over a longer period of time. The Committee will continue to make an annual presentation for the Town Board on their findings.

Other speakers from Westchester County were John Baker, Director of Conservation for Westchester County Parks and Dan Aitchison, Senior Curator of Wildlife, County Parks and Recreation. John Van Sicklin, an avid hunter, was also in the audience. John Baker said that the County can help with quality research in Pound Ridge if the program continues. Dan Aitchison does pellet counts and browsing surveys and can determine quite a bit from doing that. There used to be approximately 64 deer per square mile in 2008 and that is reduced to fewer than 20 deer per square mile in 2014. There is less browsing which means greater under-story. They have also planted oak seedlings to see how much browsing is being done.

Board Action: Motion by Councilwoman De Palma, seconded by Councilwoman Schwartz, the Board polled and motion passing 4-1 with Councilwoman Boak, nay, on the following:

RESOLVED, that the Town Board hereby approves the extension of the Deer Management Program for five (5) years provided we get the annual report each year as we have in the past.

• Discussion on Waste Water Treatment Committee

Councilwoman Boak is proposing that the Town create a new task force to address water and wastewater in Scotts Corner. Supervisor Lyman said that while he felt that when this first came up, it was premature because of the things that are happening in Scotts Corner and that we would be working with cross purposes, he now welcomes the idea of finally having a substantial discussion on wastewater after working on this issue for such a long time. The proposed task force will help facilitate efforts to secure grants to explore all options in solving waste water treatment and disposal for Scotts Corner. Councilwoman Boak mentioned that about a month ago, New York State announced \$200 million in funding specifically for municipalities to address their infrastructure issues, water and wastewater. This is through the Water Infrastructure Improvement Act. This is an

opportunity for us to go after some matching funds, 60% State and 40% Town. We are one to two years away of being in the position to apply for these grants. The amount of work in terms of defining a project area, a feasibility study and in terms of having a shovel ready project is not a small undertaking. Doing all of those steps requires a very concerted, collaborated community effort. Councilwoman Boak suggests forming a special Task Force consisting of a very specialized group of people from the community who have expertise related to this issue. The funding has only been authorized for three (3) years, one of them including 2016, so we don't a lot of wiggle room. She is proposing a real bipartisan effort and would like to see two (2) co-chairs and a group of people who are qualified and experienced similar to the committee for the TEP project. She has spoken with the Business Association and the Pound Ridge Partnership and they all seem to be supportive of this task force.

Some discussion took place regarding who is entitled to this grant regarding the median income. We would have to be below 150% of the State's median household income. Pound Ridge doesn't fall below this and in the past we couldn't apply. By speaking with the Environmental Facility Corps, Councilwoman Boak figured out that there is another way of doing it. The way to do it is to conduct an income survey of just the project area. Our project area would be PBA, PBB and PBC. They would collect the income data from any household in that project area, analyze it, develop an engineering report prepared to New York State specifications, and if it come out below the median household income of approximately \$86,000, then we could apply for the funding. We would still have to compete with other Towns in NYS, but at least we could get the application in.

FURTHER RESOLVED, that the Town Board hereby appoints Supervisor Richard Lyman and Councilwoman Alison Boak as co-chairs of the newly established Wastewater Ad-Hoc Task Force.
