PUBLIC HEARING: Continuation of the Public Hearing on CCA

Board Action: Motion by Councilwoman Boak, seconded by Councilwoman Schwartz, all voting aye to re-open the Public Hearing on Community Choice Aggregation (CCA).

The Community Choice Aggregation or CCA allows towns to buy electricity and natural gas in bulk, which leads to lower energy bills and increase the supply of renewable energy. The New York State Public Service Commission has granted permission for Westchester municipalities to implement the program. The Town of Pound Ridge is seriously considering adopting a Local Law to establish a Community Choice Aggregation (Energy) Program. The potential benefits of CCA programs include price stability for affixed contract term, lower prices, more favorable contract terms and the ability to design a program that reflects local preferences and needs.

There are two issues that concern the Town Board before we can formally adopt the Local Law to Establish a Community Choice, Aggregation (Energy) Program in the Town of Pound Ridge and they are:

- Counsel Harrington has inserted language in §5. Choice of Energy Supplier; Opt-Out Notice and Procedure to include: CCA Program Bundled Customers shall be permitted to cancel their enrollment at any time and for any reason at no cost to the Customers.
- Counsel Harrington added §7. **Indemnification** as follows:
 - A. Sustainable Westchester shall indemnify and defend the Town for any legal claims, lawsuits or damages arising from or related to the implementation and operation of the CCA Program including, without limitation Sustainable Westchester's obligation to protect all customer information as provided in §4(F). For the duration of the CCA Program, Sustainable Westchester shall maintain liability insurance naming the Town as an additional insured to cover all of the aforesaid legal claims in an amo9unt to be approved by the Town Board which shall not be less than \$1 million.

Scott Fernqvist, Pound Ridge Energy Action Committee Chairman and Glen Weinberg tried to assure the Town Board that there probably will never be a cost to opt out of the program but that there may be that possibility down the line. The Town Board wants the opt out to be of no cost to our residents. This will be discussed further with Mike Gordon Co-chair, Sustainable Westchester who feels that it can and should be delineated in the resolution but kept out of the Local Law because it may restrict the Town from creating longer term contracts for other purchasing options.

The other issue with indemnifying the Town has to be further discussed with Mr. Gordon and Sustainable Westchester because Mr. Gordon would like this to be mutual indemnification and the Town Attorney and Town Board do not agree with that. The Town's insurance company only covers what information is on our computers, not what information is forwarded to an outside computer. that Sustainable Westchester has cyber coverage and that the Town is named as an additional insured under their policy. Scott Fernqvist and Glen Weinberg said that the only information they need are the names and addresses of our residents and possibly the NYSEG account number and that cyber insurance is not necessary. They plan to use the information for mailings and not store the information, limiting potential risk for residents and businesses. Town Attorney Harrington feels differently about having personal data out there. He highly recommends that Sustainable Westchester get cyber insurance and that needs to be in the Local Law. There is always the possibility of exposing the Town to some legal risk if that information was hacked.

Scott Fernqvist and Glen Weinberg will go back to Mike Gordon and try to sort out the two issues presented tonight and hopefully, get back to us on Tuesday, September 8, 2015 for our continued discussion at the Town Board meeting.
