• Northern Westchester Hospital –Joel Seligman, President and CEO, will be addressing the Town Board on updates at NWH and on general health care

Supervisor Lyman invited Joel Seligman, President and CEO of Northern Westchester Hospital, to address the Town Board on updates at NWH and in health care in general. NWH has recently partnered with Northwell Health. The hospital is celebrating 100 years of service and a lot is changing with the healthcare system. Joel Seligman is very excited about the Planetree Model that encourages human interactions; access to meaningful information; patient and family involvement in decision making; role of food in healing; healing environments; integrative therapies; spirituality and diversity. NWH is a teaching hospital and nationally recognized leader for patient-centered care. New surgical service suites are opening April 3, 2016 to include 6 new operating rooms; 14 post-operative recovery bays; expanded central sterile department and other changes to help their patients recover more quickly and have less post-operative conditions.

As a part of Northwell Health, NWHC is now affiliated with Care Connect, an Insurance Company subsidiary started and owned by Northwell Health.. They also have GoHealth Urgent Care facilities to help patients avoid the emergency room for non-emergency care.
