NEW BUSINESS:

 The Pound Ridge Partnership-amend the approval of Special Event Application for Pride Day

The amendment to the Special Event Permit has been withdrawn by the Pound Ridge Partnership.

• Green Streets Committee- Presentation on Parking Lot Lighting

James Best, committee members of the Green Streets Committee, which is a collaboration between Pound Ridge Partnership and the Business Association and Louis Fusco, landscape architect and their consultant presented their proposal for replacement of parking lot lighting in Scotts Corner. Since 2011, the Committee has been actively looking to replace the street lights on Westchester Avenue. Then the TEP project came through taking care of Westchester Avenue; however, they were actively fundraising at that time and had very successful fundraisers as well as starting an "Adopt a Street Light" program in which people could donate and buy a street light and have a plaque put on. They decided to change the lighting in the parking areas in conjunction with what is proposed in the TEP project. Mr. Fusco showed the drawings of the proposed lighting to be used in the back parking lots. They would be replaced with LED square lighting fixtures. They are more economical and gives better coverage. The more decorative light posts will be used along Westchester Avenue working with the consultants for the TEP project. The Green Streets Committee will be adding two additional light posts, one alongside of Chubbies Hardware and one on the side of Avant Garden and North Star Restaurant as these areas were rejected in the original TEP project. The light posts on Westchester Avenue will hold the plagues donated by families. This has been cleared with the TEP representatives.

Discussion took place regarding Town ownership of these light posts and light heads and how the Town would now be responsible for maintenance and cost of NYSEG bills. NYSEG owns the wiring at this time and there have been problems but apparently, most of the wiring will all be replaced with the TEP project. The larger issue is if this becomes a public project even though it is being paid for by a non-for-profit group. It depends on who is doing the contracting. It is a grey area. Discussion will continue on this.

Carrie Sears suggests issuing a proclamation and adopting the resolution; planting milkweed plants along the Town Park and Westchester Avenue and swamp milkweed around the pond at the Town Park and possibly butterflyweed near the Town Park entrance and launching public communication effort to plant monarch gardens at the Pride Day Event by setting up a table.

Woodard and Curran – to review and discuss contract

Woodard and Curran, our consulting engineers to the Planning Board and the Town, has proposed a contract for their scope of services. The proposed contract was given to Town Attorney William Harrington for his review and comments and Supervisor Lyman and Clay Fowler, Planning Board Chair also reviewed it and made comments. Councilman Paschkes asked if this was truly an "at will contract" allowing us to get out of it at any time and that is correct. He also commented on Section F under Application Type Classifications where it addresses "escrow budgets may be required to be adjusted accordingly". It appears to give that discretion to the Chair of the Planning Board when normally the Planning Board sets the escrow amounts at a Public Meeting. The two issues are that it should come back to the Planning Board to approve at the next public meeting and also, there is nothing in the contract that notifies the applicant of the increase. Supervisor Lyman suggests striking the word Chairman and leave it as the
