OLD BUSINESS:

• CCA

Community Choice Aggregation (CCA) has been in effect for a year and Scott Fernqvist would like to revisit this program and brief the Town Board. Supervisor Lyman would like to invite him to address the Town Board at our February 9, 2017 Work Session. The Town Board agreed to have the CCA the only item on the Work Session Agenda.

Supervisor Lyman mentioned another initiative to consider would be the Solarize Westchester Program as well as the Municipal Solar Buyers Group. Supervisor Lyman was on a webinar for municipalities to be able to provide the space for a Solar array which would be no cost to the Town; however, we would have to agree to purchase the tower and a couple of caveats would be that the Town would be responsible for a 2% escalation in the cost of the power purchased per year as well as a 25 year contract. We will be examining this in the near future.

• BCSD-Discuss letter from Superintendent Manno

The Bedford Central School District wishes to build upon and strengthen the relationships that exists with our constituent town leaders. They would like to establish a subcommittee of the Board of Education to meet with a subcommittee of the Town Board members to discuss items of interest to both parties. This may happen twice a year. Councilwoman Schwartz and Councilman Paschkes will be the members representing the Town Board. Supervisor Lyman will send a memo to Superintendent Manno alerting him of this decision and send him the Town Board member's contact information.

Board Action: Motion by Councilman Paschkes, seconded by Councilwoman Schwartz, all voting aye on the following:

RESOLVED, that the Town Board hereby authorizes David Goldberg, Superintendent of Recreation, to research the purchase of a used or certified used minivan from a local dealer and purchase it if found to be satisfactory after inspection by our Highway Mechanic not to exceed the twenty thousand (\$20,000) dollars that has been allocated in the 2017 budget for this purchase. Councilman Paschkes asked that David Goldberg follow the Procurement Cover Sheet showing he researched three (3) proposals.

• Conant Hall-discuss rental options

The Recreation Department received an e-mail from a Katonah resident requesting permission to rent Conant Hall from February 1- February 6th at the quoted price of five hundred (\$500) dollars per day for a commercial sale. The Town does not have a provision for commercial use; so the Town Board discussed whether or not they wished to address this matter. After a long discussion and mentioning a few scenarios, it was decided to leave the policy as is leaving the rentals to residents and for non-commercial use. There were too many questions regarding traffic and parking and wear and tear of Conant Hall. Councilman Paschkes mentioned that we have specific requirements with our filming ordinance and the same should be followed by renters.

• Highway Department-to approve Agreement for the Expenditure of Highway Monies

There is an agreement for the expenditure of highway moneys between the Town Highway Superintendent and Town Board members of the Town of Pound Ridge. Pursuant to the provisions of Section 284 of the Highway Law, they agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

- 1. GENERAL REPAIRS: the sum of \$150,000 shall be set aside to be expended for primary work and general repairs upon 69 miles of the Town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or renewals thereof.
- 2. PERMANENT IMPROVEMENTS: Various sums shall be set aside to be expended for the permanent improvements of the Town highways. A list of roads and the amount needed is written in the agreement.

The Town Board members will all sign two (2) original agreements along with the Superintendent of Highways and forward one original to Westchester County and keep one original in our files.

Board Action: Motion by Councilman Paschkes, seconded by Councilwoman Schwartz, all voting aye authorizing Supervisor Lyman and Town Board members to sign the Agreement for the Expenditure of Highway Moneys.

• Conservation Board-Westchester Community Foundation letter of intent

Carrie Sears, Chair of Conservation Board, introduced Carsen Peck, junior Conservation Board member to the Town Board. He briefed the Town Board on what he has been doing so far and how he wants to give back to the community by being environmentally active.

Carrie Sears mentioned that Krista Munger, Land Steward for the Pound Ridge Land Conservancy will be planting trees at the Halle Ravine Preserve where they removed a lot of invasive plant species. Another program available is the Arbor Day Foundation is working with utilities to provide trees to residents. The NYS DEC Forestry will meet the cost with NYSEG. The residents can sign up for the trees and go online to itreetools.org and properties come up on google map. They can ask where to put the trees for the reduction in heating and cooling costs.

Carrie Sears mentioned that she is working on two (2) grants. She will apply for the NYS DEC Urban Forestry grant in order to inventory trees and for a forest management plan of specified town properties (Town House, Town Park and Slade Preserve). She explained that there is no cost to the Town, (no match); to contract with professionals to do the work. She will eventually need an endorsement or letter of permission from the Supervisor to do this work.

The other grant she is working on includes habitat inventory. The purpose of the Westchester Community Foundation letter of intent is to complete the habitat inventory of Pound Ridge (portions within the Long Island Sound Watershed) that were not covered under the Croton Watershed.

Carrie Sears did mention that she would like the Town Board to consider putting funds into the Conservation Board line to help fund the upcoming project (if it comes to fruition) including the Hudsonia Contract.

Whereas, trees are a renewable resource giving us paper, wood for our homes, fuel for our fires and countless other wood products, and

Whereas, trees in our Town increase property values, enhance the economic vitality of business areas, and beautify our community, and

Whereas, trees, wherever they are planted, are a source of joy and spiritual renewal.

Therefore, I do hereby proclaim the 28th day of April 2017 as ARBOR DAY in the Town of Pound Ridge,

And I urge all citizens to celebrate Arbor Day in the future and to support efforts to protect our trees and woodlands, and

Further, I urge all citizens to plant trees to gladden the heart and promote the wellbeing of this and future generations.

• EOH Watershed Corp.-SEQRA authorization

EOHWC is responsible for continuing the implementation of hundreds of storm water retrofit projects on behalf of its member municipalities. Most of the projects require environmental review under the State Environmental Quality Review Act (SEGRA). The request is for the Town to agree to EOHWC serving as lead agency in the coordinated review of any, and all SRPs that it may be undertaking in our municipality.

RESOLVED, that the Town Board hereby approves the East of Hudson Watershed Corporation's request to be designated the lead agency when EOHWC is funding and implementing projects.

• Town Park-discuss pool repairs

Supervisor Lyman said that he has been reviewing the old documents on the Town Pool. There was mention of a leak back in 1991. In the current bid specifications, there was not mention of any leaks. There are a couple of options to correct the current leak:

- have a guy get in the pool in a wetsuit and have him run aquapoxy along the whole seam of the pools for approximately \$1,000;
- put out an RFP to hire an engineer to properly diagnose/assess problem and create a specification for repair;
- rehire the consultant we already had to direct the project, basically ripping out the old gutter and pour a concrete gutter. It won't expand and contract the way stainless steel did. The County Health Department must agree to this and it may be very costly.
- The Recreation Department would like to redo the kiddy pool; we can roll both projects into a bond to fix the other pools at the same time.

Councilman Paschkes expressed his frustration over the fact that we have addressed this same problem many times and it hasn't been resolved. He would expect we could go after the Project Consultant. Counsel Harrington will review the documents and report back to the Town Board.
