Hi Dick,

You may remember me from the noise ordinance situation a ways back. Well, now I'm a Pound Ridger seven years. And I'm writing you in regards to a personal short film I plan on making in mid to late June. It's basically a comedy about stay at home dads and will be 40 minutes long. I hope to screen it at film festivals around the country. The shoot will be 5 weekdays in June during daylight hours. The total budget is quite low and coming from my savings. Our crew and cast will be less than 10 but more than five. We will NOT be a Hollywood type production at all, but more resemble a student film crew. Many involved are volunteering their time.

In getting the permit process underway, I see no problem with providing the proper insurance requirements, and paying for any police support if needed. But I'm wondering if the town would consider waiving the daily shoot fee. I ask because this is not a commercial venture but a personal one. The fees would take up a large chunk of my budget, and the majority of the shoot is in a private home. I've already secured permission to shoot at The Kitchen Table restaurant and Avantgarden store for no charge.

I'd a where meeting June 1st and present the shoot plan in detail for all members. I'd also be willing to send you a detailed shoot plan prior, and set up a private meeting if that's easier. I plan on submitting an application for the permit this week, and of course, I'll pay that fee. The application will also have a lot of details about where/when.

Dear Supervisor Lyman:

Section 2019-a of the Uniform Justice Court Act requires that town and village justices annually provide their court records and dockets to their respective town and village auditing boards, and that such records then be examined or audited and that fact be entered into the minutes of the board's proceedings.

The Unified Court System's *Action Plan for the Justice Courts* includes initiatives to improve accountability and controls over Justice Court finances and records. Among the initiatives is increased monitoring of town and village board compliance with section 2019-a.

Accordingly, I am requesting that you provide a copy of your most recent audit or examination (calendar year ending 2016 or fiscal year ending in 2017) of your local court's records and a copy of your board resolution acknowledging that the required examination or audit was conducted.
