### Resolution opposing the State of Connecticut's plan to impose a toll on I-684

Supervisor Hansan proposed the following resolution:

WHEREAS, the Town of Pound Ridge, in conjunction with Westchester County, has always welcomed a partnership with our neighbors in Connecticut and has worked cohesively on the issues that connect us, including Westchester County Airport, the Long Island Sound, and other border matters; and

**WHEREAS**, the Town of Pound Ridge understands that Connecticut has a significant budget gap to close, as well as outstanding infrastructure needs, and is sympathetic to the need for revenue, yet also recognizes that those needs are not unique to the State of Connecticut; and

WHEREAS, the State of Connecticut has proposed a toll site on the onemile stretch of Interstate 684 in Greenwich, which is used primarily by New York traffic for both trucks and passenger cars, where a toll to benefit the State of Connecticut would be an unfair taxation to those who do not have a voice, which the Town of Pound Ridge strictly opposes; and

**WHEREAS,** Connecticut stands to gain an estimated \$5 million dollars per year in revenue from the Greenwich toll, a tax that would largely be on the backs of New York State drivers, which the Town of Pound Ridge also opposes; and

WHEREAS, the Town of Pound Ridge does not believe in retaliatory border tolls between neighboring states, as this will create an unhealthy relationship where even with a toll on trucks only, avoidance traffic would follow on New York's local roads, creating a quality-of-life issue for all who live and work nearby. As well, the proposed toll is virtually certain to push traffic onto local roads causing congestion, road damage and higher risk of collisions.

**NOW THEREFORE BE IT RESOLVED,** that the Town of Pound Ridge recognizes this toll as an enhancement to Connecticut's infrastructure by imposing a toll on New York State's truck drivers and commuters without justification and stands in support of Westchester County Executive George Latimer's submitted written testimony opposing the toll; and

**BE IT FURTHER RESOLVED**, as New York has not requested or received financial contributions from Connecticut with respect to the maintenance of the roadway or with respect to the emergency calls, that the Town of Pound Ridge joins Westchester County Executive George Latimer in urging Connecticut lawmakers to forego the proposed toll.

## • Resolution condemning Anti-Semitism in Westchester County

Supervisor Hansan also proposed the following resolution:

WHEREAS, in recent weeks and months, notably throughout the festival of Chanukah, there have been escalating incidents of anti-Semitism, hatred and divisiveness, such acts including anti-Semitic invective, vandalizing synagogues and other buildings with swastikas, broken glass, and overturned menorahs; violent attacks on Jewish people in public, during worship and in their homes; and

**WHEREAS,** such instances include recent crimes in Monsey, Yorktown, New York City; and

**WHEREAS**, the FBI notes that nationwide in 2014 609 anti-Jewish hate crime incidents were reported, a number that increased nearly 40% by 2018; and

**WHEREAS**, the FBI reports that nationally in 2018 there were 7,036 single-bias-related incidents that involved 8,327 offenses, of which, 59.5% were motivated by race/ethnicity/ancestry bias, 18.6% by religious bias, and 16.9% by sexual-orientation bias; and

**WHEREAS**, according to the Anti-Defamation League (ADL), which tracks anti-Semitic and other hate incidents, anti-Semitic incidents were at historic levels in the United States in 2018, with occurrences of assaults alone up 105 % from 2017 to 2018; and

**WHEREAS**, the ADL states that preliminary analysis of 2019 data shows that New York will have recorded the most anti-Jewish hate crimes since 1992; and

**WHEREAS**, there is an urgent need to ensure the safety and security of our Jewish communities, including yeshivas, synagogues, schools, and other institutions; and

**WHEREAS**, the Town of Pound Ridge has a long history of standing up, speaking out and protecting human rights and has been asked to consider the adoption of a statement re-affirming its policies and practices as an open and affirming community, one that decries and denounces acts of anti-Semitism; and

**WHEREAS**, the Town of Pound Ridge takes pride in its enriched diversity, enriched by people of differing races, sexual orientations, gender identities, abilities, ages, and places of birth and origin; and

**WHEREAS**, the Town of Pound Ridge considers it our moral obligation and our obligation as the elected representatives of the community to work with other community leaders to condemn acts of hate against the Jewish community and all who are targeted for their differences.

**NOW THEREFORE BE IT RESOLVED,** that the Town of Pound Ridge condemns the anti-Semitic attacks here at home and on our Rockland County neighbors and stands in solidarity with the people of Yorktown, Monsey and New York City and in rejecting all forms of bigotry, hatred, or discrimination of any kind; and

**BE IT FURTHER RESOLVED**, that hate will have no home in the Town of Pound Ridge; that we are committed to promoting openness, inclusion, freedom and mutual understanding by ensuring all people regardless of race, religion, sexual orientation, gender identity, national origin or immigration status may live free from violence, harassment or prejudice; and that our Town will make every effort to ensure that our community is one where all people are welcome, included and respected; and

**BE IT FURTHER RESOLVED,** that the Town of Pound Ridge will work with other levels of government and community groups to root out hate and promote understanding and that we encourage other municipalities to join this resolution and to join forces in ensuring that the vile history of anti-

Semitism and other forms of intolerance in New York and around the world, ends now and ends here; and
