A. Deer Management Program – Presentation of 2019 Final Report

that can best be evaluated after a minimum of twenty years of implementation; however, the number of motor vehicle accidents involving deer has already declined significantly.

Superintendent of Recreation & Parks David Goldberg recommended engaging Nu-Clear Swimming Pool Service to perform a temporary repair to leaky joints in town swimming pools at a cost of \$16,775. Councilman Paschkes expressed concern that the one-year warranty was too limited, and asked that the board delay its vote until the March 3 meeting to give the Town Attorney time to review the warranty language.

D. Tax Assessor – Request for STAR Refund for the 2019-2020 school year

Councilperson Brand reported that the Energy Action Committee and the Conservation Board are excited to support Earthshot 2030, a community action day scheduled for April 19, 2020.

Councilperson Boak reported the following news from the Recreation Commission:

- William Sheridan will construct a "fishing kiosk" near the Pond House in the Town Park as an Eagle Scout project.
- The Pound Ridge Players, a new community theater project organized by Tami McCarthy, will soon begin meeting two Wednesdays a month in Conant Hall.
- Pete Kelly has proposed installing a turf field at PRES in collaboration with the Love4Lucas Foundation.

Councilperson Boak also reported that the Water Wastewater Task Force will visit Hillsdale, in Columbia County, to learn about its recently installed septic system, which is similar to a system being considered for Scotts Corners.

Councilperson Briggs, the liaison to Census 2020, cited the need to educate residents about the importance of responding promptly when they receive census information in the mail to avoid visits by census workers. Chief Ryan agreed, noting that the more houses census workers have to visit, the more unnecessary complaints the Police Department is likely to receive.

FUND TRANSFER:
