# A. County Executive George Latimer – COVID-19 Vaccine Update

County Executive George Latimer provided an update on COVID-19 vaccine distribution, which is controlled by New York State. Eligible populations include people age 65+, first responders, and certain categories of essential workers.

County Executive Latimer said that it would be helpful to the county if the town could identify locations for possible pop-up vaccination centers, could identify first responders who have not yet been vaccinated, and could identify homebound individuals who need to be visited in order to be vaccinated. Supervisor Hansan said that the town's Office of Emergency Management has already done these things. Possible locations for mass vaccinations include Conant Hall, the Town House, and the Town Park.

#### B. Assessor – Adoption of resolution related to renewal of exemptions pursuant to Real Property Tax Law sections 467 and 459-c for tax year 2021

## **RESOLUTION 28-21**

WHEREAS, on December 28, 2020, the Governor Andrew Cuomo signed into law the COVID-19 Emergency Eviction and Foreclosure Prevention Act of 2020 (the "Law"); and

WHEREAS, in the interest of the health and safety of the public amidst the continuing COVID-19 pandemic, Subpart D of the Law mandates that every governing body of an assessing unit and local assessor shall automatically extend to the 2021 assessment roll the renewal of the exemptions received on the 2020 assessment roll pursuant to Section 467 of the Real Property Tax Law, relating to persons age sixty-five and older and for certain persons with disabilities and limited income; and

WHEREAS, recognizing that eligibility status for the applicable exemptions may have changed, potentially resulting in a greater tax benefit for the property owner, Subpart D also stipulates that the local assessor shall make available and process renewal applications from property owners having experienced a decrease in income or some other qualifying event that would result in a greater exemption than what was present on the 2020 assessment roll; and

WHEREAS, because certain changes in eligibility status may alternatively result in a reduced exemption benefit, Subpart D further provides that such governing body may adopt a resolution including procedures by which the assessor may require a renewal application to be filed when s/he has reason to believe that an owner who qualified for the exemption on the 2020

> assessment roll may have since changed his or her primary residence, added another owner to the deed, transferred the property to a new owner, or died; and

WHEREAS, to support equitable distribution of the property tax burden, staff recommends that the Town Board exercise the local option to adopt a resolution authorizing the assessor to require a renewal application when she has reason to believe that a property owner no longer qualifies for an exemption granted on the 2020 assessment roll, pursuant to the following procedure:

In response to a change in eligibility status observed by or reported to the Town Assessor, s/he shall:

- 1. Provide a renewal application to the property owner of record either electronically or by U.S. mail;
- 2. Require the application to be returned in-person, by U.S. Mail, or electronically, by a date certain, and in no case later than May 1, 2021, such that any change in exemption status is properly reflected on the 2021 assessment roll;
- 3. Verify the completeness and accuracy of any returned application and make any necessary property tax exemption modification in connection with a change in eligibility; and
- 4. Provide notice to the owner of record of any change in exemption eligibility status; NOW THEREFORE, BE IT

RESOLVED, pursuant to Subpart D of the COVID-19 Emergency Eviction and Foreclosure Prevention Act of 2020 and in the interest of equitable property tax distribution, the Pound Ridge Town Board hereby authorizes the Town Assessor, subject to the procedure outlined herein, to require in his/her reasonable discretion that a renewal application be filed by any person(s) who received any exemption(s) in connection with Real Property Tax Law Section 467 on the 2020 assessment roll who may have since changed his or her primary residence, added another owner to the deed, transferred the property to a new owner, or died. # H. The Invasives Project – Authorization for herbicidal control in Lawther Preserve and Sachs Park

Carrie Sears, co-chair of the Invasives Project, asked that the board approve the targeted use of the herbicide Pathfinder to eradicate sapphire berry plants in Lawther Preserve and Sachs Park. The treatment would be administered by a licensed applicator, and this would be done at no cost to the town. The agreement provided to the board by did not specify the type of herbicide to be used and indicated only that the town would be notified before application. There was no provision for the town to rescind permission after learning which herbicide would be used. Town Attorney Bill Harrington asked that the agreement be amended to specify the herbicide to be used and that fact sheets be provided for the board's consideration. The matter will be reconsidered at a later date.
