WHEREAS solving the water/wastewater problem, which has plagued the Scotts Comers business district for more than three decades, is **the top priority for our town**; and

WHEREAS investing in water/wastewater is critical to protecting and raising our residents' quality of life, the prosperity and smart growth of our business district, and the ability of seniors and young families to remain in town; and

WHEREAS the Town of Pound Ridge seeks funding to build a wastewater treatment and disposal system for Scotts Comers, the main commercial and retail area of Pound Ridge; and

WHEREAS the present situation is unsustainable, limits any future growth in the Scotts Corners area, and if left unaddressed, will lead to future failures of existing wastewater treatment systems, as many lots have antiquated wastewater treatment systems that are still in use; and

WHEREAS the Town of Pound Ridge has historically advanced policies and practices that preserve natural resources, promote the use of clean energy, address the dangers of climate change, and otherwise protect our environment; and

WHEREAS federal funds are available to implement appropriate energy saving improvements in the Town House that would result in the saving of substantial energy and that would advance the safety, health, and welfare of the employees and residents of the Town of Pound Ridge; NOW THEREFORE BE IT

RESOLVED, that the Town Board of the Town of Pound Ridge hereby supports and authorizes the Water/Wastewater Task Force's application to Congressman Sean Patrick Maloney's office for community project funding for the purposes of developing a wastewater system in the Scotts Corners Business District; and BE IT FURTHER

# F. Sustainable Westchester - Community Choice Aggregation Program Update

Jasmine Graham, Manager of Westchester Power, reported that through its participation in the Westchester Power Program, which enables the bulk purchasing of renewable electricity in the form of emissions-free hydropower. Through its participation in this program, Pound Ridge has offset a total of 3,475 metric tons of carbon dioxide, which is equivalent to removing 756 cars off the road for a year or planting 13.7 million tree seedlings and allowing them to grow for ten years.

Spanish-language customer service is available. Recently, a number of customers have called after having received unusually high bills from NYSEG, which delivers electricity purchased through Westchester Power. The fluctuation was unrelated to Westchester Power; it occurred because NYSEG sent estimated bills for several months before performing actual meter readings.

Ms. Graham also reported on opportunities for residents who opt into the Community Solar program to receive rebates of up to ten percent of their energy costs. Councilwoman Brand asked when Solar Credit rebates will be consolidated into NYSEG billing, and Ms. Graham responded that this should occur by midyear. Once consolidated billing is in place, Community Solar will be available to municipalities on an opt-out basis.

Westchester Power is currently seeking 2021 bids from energy suppliers through a reverse auction process. Notification letters will be sent to consumers in October 2021 for rates that will begin in December. Residents will be able to opt out of the default clean energy option at any time at no charge.

# G. Liaison Reports

Councilperson Boak reported that responses to the Water Wastewater Task Force's RFP are due Friday, April 16, 2021.

Councilperson Brand reported that there will be a tree dedication at Lions' Park on Friday, April 30, 2021, to honor first responders' efforts during the pandemic. The white oak that is to be planted will be funded by a grant from the Arbor Day Foundation obtained by the Conservation Board. She also noted that the Friends of Pound Ridge will be hosting a Low Waste Exhibition at the Market Square on Sunday, April 24, 2021.

Councilperson Briggs reported that the Recreation Commission is working to ensure that summer activities will proceed as usual, though with additional social distancing. She also said that construction documents for the Village Green should be forthcoming soon.
