# **ANNOUNCEMENTS:**

- There will be a public hearing on August 10, 2021 regarding the proposal to lower the speed limit on local roads west of Long Ridge Road.
- The rescheduled fireworks display will be held Saturday, August 7, 2021, in the Town Park. Please note that an earlier sunset means that fireworks will start earlier than in past years. Parking permits—free for residents and \$30/car for nonresidents—will be required. They will be available at the Police Department starting Monday, July 19.
