CALL TO ORDER: Supervisor Hansan called the meeting to order at 8:05 pm.

ANNOUNCEMENTS:

- Thank you to Chief Ryan, the Fire Department, the Recreation Department, the Maintenance Department, and everyone else who assisted with the fireworks.
- Residents are encouraged to check on their neighbors during the heat wave that has been forecast for later in the week.
- There have been a number of bear sightings recently. Please be bear aware!
- The Village Green project has gone out to bid.

MINUTES:

Board Action: Motion by Councilperson Boak, seconded by Councilperson Briggs, all voting aye, to approve the minutes of the June 8 and July 13, 2021 Town Board meetings.

PUBLIC HEARING:

Board Action: Motion by Councilperson Paschkes, seconded by Councilperson Boak, all voting aye, to open a public hearing on a proposed speed-limit reduction to 25 mph in the Shad Road West neighborhood.

Supervisor Hansan noted that there has been a significant increase in pedestrian activity due to the pandemic and pointed out that the neighborhood in question does not have through traffic because there are no connector roads. Police Chief David Ryan said that because of the lack of connector roads, the people who are

speeding are residents of the neighborhood, their guests, and commercial vehicles belonging to service providers who work for residents. Traffic studies show that only about 9% of vehicles are exceeding the current speed limit.

Resident Jessica Watts expressed concern for pedestrians and support for a reduced speed limit. Resident Dawn Davidson noted that many pedestrians come from the far side of Long Ridge Road.

Councilperson Boak asked why residents might be opposed to the change. Chief Ryan said that people may view 30 mph as a safe speed limit, not realizing that the police can issue tickets only for drivers who significantly exceed the limit. Ms. Watts said that the only person who criticized the proposal was a longtime resident who seemed to be opposed to change in general.

Resident John McCown said that a lower speed limit is important to protect cyclists. Several residents participating via videoconference also expressed support for lowering the speed limit. Resident Karen Close, who is the parent of two children with autism, noted that she worries about her children wandering into the road, especially since she has observed cars traveling at excessive rates of speed.

Resident Susan Lee said that enforcing the speed limit by issuing tickets to residents would be an effective way to change behavior. Councilperson Paschkes reiterated that people who support the change need to understand that their neighbors, their neighbors' children, and their neighbors' workers will be ticketed.

A. Supervisor – Approve resolution for speed limit reduction in Shad Road West neighborhood

WHEREAS many of the Town roads west of Long Ridge Road are unique to the Town as they are straight and relatively wide; and

WHEREAS, as a result of the configuration of such roads, local families and children ride bicycles and partake in other activities on such roads; and

WHEREAS residents of the Town who reside west of Long Ridge Road have requested that the speed limits on such roads be lowered from 30 miles per hour to 25 miles per hour to enhance the safety of residents and visitors; and

WHEREAS, the Pound Ridge Police Department has commented favorably on lowering the speed limit on such roads, NOW, THEREFORE, BE IT

RESOLVED, by the Town Board of the Town of Pound Ridge as follows:

Section 1. The speed limit on the following roads west of Long Ridge Road is hereby established as 25 miles per hour: Shad Road West, White Birch Road, White Birch Road South, White Birch Lane, Pheasant Road, Pheasant Road West, Robin Hood Road, Gorge Lane, Sherwood Road, Cedar Hill Lane, Fox Hill Road, Calf Pasture Lane, Bob Hill Road, Sunset Lane, Apple Tree Lane, London Road.

Section 2. This resolution shall be effective upon the posting of 25 mile per hour speed limit signs at the above described roads or at the entrances to roads after turning off of Long Ridge Road to travel west.

B. Pound Ridge Fire Department

Fire Chief James Dodge asked that the Town Board consider amending the building code to require a shutoff switch on electric vehicle charging stations. Town Attorney Bill Harrington and Building Inspector Jim Perry will confer regarding language and specifications. In the interim, Chief Dodge will ask Inspector Perry to alert him to any applications for the installation of EV charging stations so that applicants can be made aware of the need for shutoff switches.

C. Finance – Update on YTD financial statements

Director of Finance Steven Conti reported that the town is in good shape at this point. The three significant revenue streams that the town does not control—mortgage tax, sales tax, and state and federal aid—are all above anticipated levels. Only about 40% of budgeted funds have been spent to date.

WHEREAS, in light of the information provided by the Town's independent appraiser, the Town has determined that the appropriate value for the property is \$3,400,000.00; NOW, THEREFORE, IT IS HEREBY

STIPULATED AND AGREED, by and between the Petitioner and the Town, that in consideration of Petitioner not filing an Article 78 proceeding, the Petitioner and the Town agree that the Decision in this matter should be vacated; AND IT IS FURTHER

STIPULATED AND AGREED by and between the Petitioner and the Town that the 2020 assessment on the referenced tax parcel be as follows:

REDUCED FROM: \$810,000.00 TO: \$647,700.00 A REDUCTION OF: \$162,300.00

IT IS FURTHER STIPULATED AND AGREED that the municipal officials having custody of the assessment rolls shall correct the assessment roll to conform to the Stipulation, and that if any taxes were paid based on the "reduced from" assessment indicated above, a refund of the taxes paid on the amount of the reduction of the above-mentioned assessment shall be made to the representative on behalf of the Petitioner, who is to hold the proceeds as trust funds for appropriate distribution, and who is to remain subject to the further jurisdiction of the Court with regard to its attorney's lien, pursuant to Judiciary Law §475; AND IT IS FURTHER

AGREED that this stipulation constitutes a "decision" for the purposes of Section 739 of the Real Property Tax Law; AND IT IS FURTHER

AGREED that this Stipulation represents full settlement of the Small Claims Assessment Review proceeding and that no costs or allowances shall be awarded or paid to, by, or against any of the parties.
