WHEREAS the construction of an ADA-compliant exterior entrance to the courtroom at the Town of Pound Ridge Town House consists of the expansion of a nonresidential structure involving less than 4,000 square feet of gross floor area not involving a change in zoning or a use variance and consistent with local land use controls; NOW THEREFORE BE IT

RESOLVED that the Town of Pound Ridge hereby determines that the construction of an ADA-compliant exterior entrance to the courtroom at the Town House is a Type II action in accordance with 6 NYCRR Section 617.5(c)(9) and is therefore not subject to further review under 6 NYCRR 617.
