WHEREAS, the New York Marihuana Regulation and Taxation Act ("Cannabis Law") became effective on March 31, 2021; AND

WHEREAS, Section 131(1) of the Cannabis Law provided a nine-month period ending on December 31, 2021, allowing the Town of Pound Ridge ("Town") to adopt a local law requesting the New York Cannabis Control Board to prohibit the establishment of retail dispensary licenses and/or on-site consumption licenses within the Town (hereinafter, "Local Opt-Out Law"); AND

WHEREAS, the Town did not adopt a Local Opt-Out Law on or before December 31, 2021; AND

WHEREAS, under the unique facts and circumstances of this matter, the interests of the Town and its residents will be served by requesting the New York State legislature to pass a law whereby the time for the Town to adopt a Local Opt-Out Law shall be reinstated for a nine-month period commencing on the effective date of such law; NOW, THEREFORE, BE IT

RESOLVED, that the Town hereby supports and approves a request that the New York State legislature pass a law whereby the time for the Town to adopt a Local Opt-Out Law shall be reinstated for a nine-month period commencing on the effective date of such law.

# 1. Discussion of request for relief from Local Law 2023-4

Gerri Tortorella, of Hocherman Tortorella & Wekstein LLP, appeared on behalf of PMNG Management LLC to request relief from Local Law 2023-4, which enacted a six-month moratorium on development in the zoning districts known as PB-A, PB-B, and PB-C. She stated that she believed the moratorium would preclude PMNG from obtaining a SEQRA determination regarding the proposed redevelopment of certain parcels located in the PB-B district with the construction of low-density residential apartments. Ms. Tortorella asked that the board amend the moratorium to exempt all residential development, not just one- and two-family dwellings.

Supervisor Hansan and Councilperson Paschkes both pointed out that since no application has yet been presented, it would be unlikely that the necessary work needed to obtain a SEQRA determination could be completed before the moratorium expires and that the language could be revisited if the board should choose to consider extending the moratorium. No action was taken on the matter.
