## 1. Update regarding regulation of cannabis retail business activity

Town Attorney Harrington said he anticipates that the process of circulating proposed zoning code changes will begin in April. He also noted that the applicant for a license to operate a dispensary at 32 Westchester Avenue has commenced a lawsuit against the town challenging the legality of the moratorium on development in the business district. The applicant is also seeking an opinion on the zoning code, to be addressed at the April meeting of the Zoning Board of Appeals. The town is still awaiting word from its representatives in Albany regarding legislation that might reopen the opt-out period.

Supervisor Hansan added that the firm of Hardesty & Hanover, which is already assisting with the preparation of the comprehensive plan, is willing to provide advice regarding zoning code modifications to regulate the time, place, and manner of cannabis retail business activity.

Mr. Cianciola then asked why the Highway Department unionized.

Supervisor Hansan responded that it was the choice of the Highway Department staff to unionize. Town Attorney Harrington noted that the collective bargaining agreement does not provide any benefits already contained in the personnel handbook. Councilman Paschkes pointed out that the decision to unionize has cost Highway Department employees in terms of dues but has not resulted in any additional costs to the town.
